TERM AND CONDITIONS OF THE TENDER

(including GST if applicable)

1. The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender papers correctly and in complete form. The tender paper should be filled in properly and legibly without any correction/overwriting and must be a typed copy/computer type copy. No opportunity shall be given to the tenderer to rectify or amend any defect detected at the time of scrutiny. The rates should be written both in words and figures in the tender. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for one year from the date of assignment of the work.
2. The tender paper will be in two parts i.e. Technical Bid (part 1) and Financial Bid (part 2). The tenderer should submit both the paper separately in two envelopes and put into another cover super scribed in capital letters ‘ **TENDER FOR ENGAGEMENT OF TRANSPORT AGENT OF NUAPADA DISTRICT UNDER SNP/WBNP/SAG SCHEME**’ for the year 2025-26.
3. The maximum limit of transportation cost of irrespective kilometer is Rs. 150/- (Rupees Seventy Five Only) per Quintal including Loading/Unloading and other charges from OSWC/FCI Depot to 1408 AWC point and WSHG-THR UNIT.
4. The tenderer shall have experience in transportation of food grain in any State/ Central Govt. Agency and should have carried out in any of the preceding financial year.
5. The Vehicle should have National/State permit for transportation. "No Individual, company, firm, corporation shall in the tender process unless it obtains or possess valid Registration Certificate in support of their transportation work under the Carriage by Road Act,2007 & the "Carriage by Road Rule,2011" issued by the State Transport Authority (STA) or Regional Transport Authority.
6. The Vehicle has to be registered in the name of Tenderer till the end of the contract period. In case the Vehicle is required to be disposed of in between the contract period, the same shall be made on prior intimation to the DSWO, Nuapada with substitute of a suitable vehicle in the name of Tenderer along with its documentary proof.
7. The Tenderer shall have minimum 02 (Two) numbers of trucks in his/her own name and additional light vehicle can be availed on hire basis. The Tender shall submit the list of Trucks in his/her own name and the list of light motor vehicle proposes for hire for the transportation job along with Registration Number and consent letter of the Vehicle Owner.

8.The Tenderer has to assess the requirement to utilize the small vehicle for transportation of food grain in interior villages of concerned Block area where heavy vehicle i.e. Truck could not operate and shall mention in the prescribed format.

9.After lifting of the Rice & Wheat from OSWC and FCI Depot.it will be delivered at AWC point and WSHG-THR making unit as far as practicable in the same day as per the route chart issued by concerned CDPOs. Any deviation regarding delay in delivery of food stuff or any shortage of quantity found, action as per law shall be taken against Tenderer. The Transport Agent shall be liable for all cost towards any damage, charges & expenses due to Agent's negligence or otherwise work done by their employees.

10.It is the responsibility of Transporting Agent to lift the Rice from OSWC and wheat from FCI depot on proper weighment and deliver the same at AWC Point and WSHG-THR unit respectively. The weighing machine to be taken by the Transporting Agent must be sealed and stamped by the Inspector of Legal Metrology, Nuapada. The Agent will be held responsible for taking delivery of the stock and damage noticed if any during transit. No shortage will be allowed to the Agent. The quality and quantity of the foodstuff being transported may be inspected by the Govt. Official authorized by Collector, Nuapada during transit and also at the delivery point.

11. The tenderer should submit the following documents along with the tender paper. In absence of any document/paper in the tender form will be liable for rejection by the competent authority. **The tenderer shall have to produce the original documents if necessary before the Tender Committee for verification.**

i) Original tender paper duly signed by the tenderer as token of acceptance of the terms & condition of the tender.

ii) Original money receipt or Demand Draft of Rs.7180/- (Rupees Seven Lakh One Thousand Eighty) only in favour of DSWO, Nuapada payable at SBI, Nuapada in support of purchase of the tender documents from the office of the D.S.W.O, Nuapada/Dist. website.

iii) Attested copy of valid VAT / GST Clearance Certificate.

iv) Attested copy of PAN Card.

v) Attested copy of the Valid Agent certificate in support of their transportation work under "The carriage by Road Act,2007 & "The carriage by Road Rule,2011" issued by State Transport Authority(STA) or Regional Transport Authority(RTA) for Nuapada Dist..

vi) Attested copy of valid latest Income Tax return for the assessment year 2024-25(Financial year 2023-24)

vii) The Tender shall furnish a certificate from any Nationalized Bank or Schedule Bank indicating his/her capability for an amount not less than Rs.25.00 lakh(Rupees Twenty Five Lakh) only. The Tender shall furnish

viii) Certificate from any Govt. Organization about past experience and performance of the Tenderer in transportation of food grain from State/Central Govt. Agency and PSU. The accepting authority shall have the right not to accept tender(s) contractors who have not performed satisfactorily in preceding years under above programme.(Format enclosed at **Annexure-B.**

ix) Earnest Money of Rs. 5,50,000/- (Rupees Five Lakh Fifty Thousand) only in shape of Demand Draft/NSC/Term Deposit duly pledged in favour of DSWO, Nuapada shall be furnished along with the tenders.

x) Affidavit to the effect that the Individual/firm does not have any legal suit/criminal case pending against the violation of PF/ESI/ or any other Law/has not been blacklisted as per the format annexed in **Annexure-C.**

12.Tenders without Earnest Money will be liable for rejection. Cash/Cheque and Bank Draft shall not be accepted. No request for transfer or any previous deposit or adjustment of earnest money for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejections of the tender paper. No tenderer shall be allowed to withdraw his tender/ Earnest Money Deposit until the tender is finalized. In case the successful tenderer refuse to be the Transporting Agent after acceptance of his tender the Earnest Money Deposited by him will be liable for forfeiture. The E.M.D of the unsuccessful tenderer shall be refunded after finalization of the tender; whereas the E.M.D of the successful tenderer will be kept as Security Deposit and will be released after successful completion of contract period, settlement of payment thereof and audit of such account. The breach of any terms and conditions as per agreement and failure/unwillingness to undertake transportation work by the selected tenderers within the time limit after acceptance of his tender may lead to forfeiture of E.M.D. The selected transporting agent will be black listed for any other Govt. Tender if he fails to perform the duties as per agreement.

13. Security Deposit furnished by the Agent shall be refunded subject to term and condition in the tender document and the Collector & DSWO shall not be liable for payment of any interest on the security deposit or any depreciation thereof, whatsoever.

14. Additional Performance Security (APS) shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to Tender. The differential cost shall be decided by the Tender Committee shall be deposited in shape of TDS pledged in favour of DSWO. Nuapada and it will be refunded after successful completion of the work. EMD of a Tenderer will be forfeited, if the Tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. **Further, if the successful tenderer fails to furnish the required performance security within the specified period, the Tender Committee shall take the final decision in the matter.**

15. The successful tenderer shall have to enter into agreement with Collector, Nuapada as per the terms and conditions mentioned in the specified agreement format within 7 (seven) days of intimation of acceptance of his tender. The cost of such registration will be paid by the Tenderer.

16. Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority and on production of printed serially numbered delivery challan of the stock duly acknowledged by the recipient of the stock to whom it concerned according to approved rate. The District Social Welfare Officer, Nuapada shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under Transportation charges head under S.N.P./WBNP/SAG feeding programme and no advance payment will be made.

17. Good conducts, dealing with officials shall be an implied condition for continuance as Transporting Agent.


18. The Transport Agent have to obtain a license from Licensing Authority as per the Odisha Public Distribution System(Control)order,2016 immediately after execution of agreement.

19. The Collector, Nuapada may terminate the contract for violation of terms and conditions of agreement as well as any change of policy in the Government or for any reasons to be recorded in writing.

20. In case of violation of conditions of Tender, the Agent will be booked under IPC, Essential Commodities Act, Prevention of Food Adulteration Act and Prevention of Black Marketing Act.

21. The right of acceptance of tender rests with Collector, Nuapada who does not bind himself to accept the lowest tender and also reserves the rights to cancel or reject any or all the tenders without assigning any reason there of . In case of any dispute arising out of this contract/agreement the orders/decision of the Collector, Nuapada will be final & binding.

The District Tender Committee reserve the right to have cross negotiation with all the qualified Tenderer, if required, to finalize the rate for transport operation. In case of any dispute arising out of this contract/agreement the jurisdiction of the court shall be at concerned revenue Dist.
