2. The sale of the Bid document shall start from Dt. 30.06.2025 and close on Dt. 18.07.2025 at 5.00 P.M. in the office of the undersigned. Bids shall be received by this office up to 5.00 PM on date 18.07.2025 through online tendering process only. The authority will not be held responsible for any delay in delivering of the Bid documents or non-receipt of the same.
3. The Bid will be opened on Dt. 21.07.2025 at 11.30 A.M. in the office of the undersigned in the presence of the bidders or their authorized representative.
4. Banking Arrangement
 - a) Designated Banks (SBI/ICICI Bank/HDFC Bank) Payment gateway are being integrated with e-Procurement portal of Government of Odisha (<http://tendersodisha.gov.in>).
 - b) The Designated Banks Participating in Electronic receipt, accounting and reporting of cost of tender paper and Earnest Money Deposit on Submission of bids will nominate Focal point branch Called e-FPB
5. Bidders shall submit original affidavit regarding authenticity of their documents along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, valid GST clearance certificate and PAN card.
6. The affidavit should clearly speak regarding the name of work for which the tender is submitted. One should mention clearly in the affidavit to avail price preference in case of SC/ST category if any.
7. Engineer Contractor seeking exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than **two** works during the current financial year.
8. Paper and earnest Money Deposit on Submission of Bids'
 - a) it will be carried out through a single banking transaction by the bidder for multiple payments like cost of Tender.
 - b) Various payment modes like Internet Banking/NEFT/RTGS of Designated Banks and their Aggregator banks as well Can be accessed by the intending bidders.
 - c) Reporting and accounting of the e- receipts will be made from a Single Source.
 - d) Credit of receipts into the Government accounts and to the designated Bank account of the participating entities indicated in para 2 above would be faster.

9. Additional performance security shall be deposited by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as APS in shape of Demand Draft / Term Deposit Receipt pledged in favor of Block Development Officer, Nuapada (Additional performance security- No Additional performance security shall be obtained from the bidder when the bid is less than 5% of the estimated cost put to tender, 50% Additional performance security shall be deposited by the successful bidder if the bid amount is 5% and above and below 10% and further 150% Additional performance security shall be deposited by the successful bidder if the bid amount is 10% and above shall have to furnish (APS) in shape of demand draft / term deposit receipt duly pledged in favour of Block Development Officer Nuapada the within 07, (Seven) days of issue of letter of acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder, otherwise the bid of the successful bidder shall be cancelled and the Earnest money deposit/ bid security deposit shall be forfeited vide office memorandum No-4559/W Bhubaneswar, dt.-05.04.2021 of Works deptt. Further, proceeding for black listing shall be initiated against bidder vide office memorandum No-14299, dt.-03.10.2017 of Works deptt.

10. Other details can be seen from DTCN.

11. If stipulation arises, tender will be decided through a transparent lottery system after Complete all Formalities.

12. The authority reserves right to reject any or all the bids without assigning any reason thereof.
