3. The tenders will be opened in presence of School Purchase Advisory Sub Committee / tenderers / their authorized representatives on **09/07/2025 at 10 AM** in the school.
4. No rate will be accepted over and above the MRP, hence it may be ensured that rates quoted by firms are below MRP .
5. Various schemes of discount and free items offered by the manufacturer / distributor have to be extended to the school.
6. It is compulsory to quote rates of all the items given in the tender form , if not quoted, Committee will decide whether he/she will be eligible to take part in tender opening or not.
7. In case of **items supplied other** than the approved brand, specifications, make or size, the same shall have to be replaced immediately by the supplier without extra cost. In case of any article supplied is not being approved, then expenses or loss caused to EMRS as a result of rejection or replacement of supplies, shall be entirely impose to the account of the supplier.
8. Principal or Principal i/c of EMRS Nuapada shall have at all reasonable time access to the supplier's premises and shall have the power and all reasonable time to inspect and examine the materials and workmanship of all the material as the case may be.
9. On delivery of times the suppliers must have submit original GST Bill / Delivery challan with purchase order to undersigned.
10. If the items supplied are found damaged, mutilated, substandard or not conforming to the standard as per contract, the same will be rejected and the supplier shall have to replace the same immediately without any extra cost. The date of supply of replacement will be treated as the date of delivery and not the original one. Any expenses incurred/loss suffered by EMRS on this supply shall be debited from the supplier's A/c.
