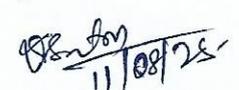

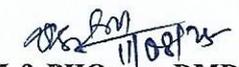

02. The Farms (s) are to submit their quotations in **Single** sealed covered envelop for both **technical bid and Price bid** by superscripting the sealed covers as "Quotation for supply Printed items.
03. Rates should be inclusive of all taxes, Transportation & installation.
04. The rate will be applicable for purchase of the above-mentioned items for one time only.
05. The supplier selected shall have the responsibility to supply above mentioned items as per supply order which is required for carrying out day to day official work.
