2. Bid Price

a) All Taxes duties and other levies related payable by the Bidder under the contract shall be included in the Bid Price/quoted Price.

b) The rates quoted by the bidder shall be fixed for the total duration of 12 months of the contract and shall not be subject to adjustment on any account.

3. Terms & condition

i) Each bidder shall submit one quotation as per the enclosed Quotation Format
ii) The Bidders are required to deposit an earnest money of Rs.10,000/- (Rupees Ten Thousand) only in shape of Demand Draft in favour of the Executive Officer, NAC, Khariar Road. Quotation paper submitted without E.M.D. shall not be accepted. The EMD will be forfeited, if a Bidder (i) withdraw his Bid during the validity period of the Bid or (ii) fails to perform the contractual obligations as per the work order. The EMD amount of the unsuccessful Bidder will be refunded after completion of Quotation process.

4. Validity of Quotation

Quotation shall be valid for a period not less than 30 days after the deadline date specified for submission.

5. Evaluation of Quotation

The NAC will evaluate and compare the quotations determined to be substantially responsive i.e. which (a) are properly signed and (b) confirm to the terms and conditions. While submitting the bid, the bidders should submit the following documents

- Copy of Sales Tax Registration No. /TIN No. /GST Registration No.
- Copy of up to date VAT Clearance certificate
- Copy of Registration certificate of the Firm/Agencies etc. if any


6. Award of Contract

- i) The work order will be awarded to the bidder whose quotation has been determined to be substantially responsive with highest quotation price.
- ii) The bidder whose bid is accepted will be notified towards award of contract by this NAC prior to expiry of the quotation validity period. The terms of the accepted offer shall be incorporated in the work order.
- 7. Payment shall be made annually after completion of the lease period through e-transfer after submission of the bills/vouchers.
- 8. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of work order may result in rejection of the bidder's offer.
- 9. Any legal dispute out of this subject to Nuapada District jurisdiction only
- 10. Not with standing the above, the undersigned reserves the right to accept or reject any quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter.
