2. The bid documents are available online and bids are to be submitted online through e-tendering portal <https://tendersodisha.gov.in>. The bidders would be required to register in the web site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA).

*Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain in the same by registering in the web site: <https://tendersodisha.gov.in>. digital signature is mandatory to participate in the e-Tendering. Bidders already possessing the Digital Signature issued from the authorized CAs Can use the same in this tender.

The Bill of Quantities shall mention Quantities of each item thereto. The Contractor has to mention his "PERCENTAGE RATE" in figures in the prescribed format appended to the Bid documents.

The Bidder/Contractor will write PERCENTAGE RATE up to two decimal points only. If he writes the PERCENTAGE RATE up to two or more decimal point, the first two decimal points shall be considered without rounding off.

3. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The procedure followed for opening of bid is specified in guidelines. The lowest bidder will be finalized after evaluating the bids.

4. The bids for the works shall remain valid for acceptance for a period not more than 180 days after the DEADLINE for bid submission.

5. Other details can be obtained from the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information / corrigendum related to the bid.

6. Tender shall be uploaded in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-procurement portal and submitted duly filled up. The on-line bidders should upload the scanned clear copy of the affidavit in support up correctness or proof of the information submitted including bid security accompanied with the tender by them. They should digitally sign on all statements, documents, certificate with an affidavit owing genuineness of the documents should also be uploaded. **The affidavit of authenticity of documents uploaded the bidders being a legal document checking genuineness of signature put on other uploaded documents including affidavit and lease deeds is beyond purview of the office inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.**

7. The Technical Bid will be opened in the office chamber of the Block Development Officer, Panchayat Samiti, Khariar online at **27.04.2026 at 11:00am** in presence of the bidders / authorized representatives who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will open on the next working day at the day of same time and venue.

8. **Additional performance security** - The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish the differential cost as tabulated below i.e. estimated cost put to tender minus quoted amount as additional performance security (APS) in shape in shape of demand draft / term deposit receipt duly pledged in favour of the Block development Officer, Panchayat Samiti, Khariar within 07 (Seven) days of issue of letter or acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder, otherwise the bid of the successful bidder shall be cancelled and the Earnest money deposit / bid security deposit shall be forfeited vide office memorandum No-4559/W Bhubaneswar, Dt. 05.04.2021 of Works Dept. Further, proceeding for black listing shall be initiated against bidder vide office memorandum No.-14299, dt-03.10.2027 of Works dept.

Amendment to codal/contractual provision
(works department memorandum no. 173 dt 03.01.2026)

After careful observation, Government has been pleased to abolish the extant provisions of threshold negative bid caps (14.99%) introduced in Appendix-IX, Clause 36 of OPWD Code Volume-II in the procurement of works undertaken by the Govt of Odisha and its agencies to ensure the procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system:

- A. Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:
 - I. where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
 - II. where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;
 - III. where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;
 - IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
 - V. The additional performance security shall be treated as part of the performance security.
 - VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document., If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

9. Grant of Concession (S) to Scheduled Caste and Scheduled Tribe Contractors. (Works Department resolution No.16262 dt.30.10.2018).

Government have extended certain concessions to the Scheduled Caste and Scheduled Tribe Contractors regarding award of P.W.D Works vide Resolution No.27748/W dt.11.10.1977. On the basis of the recommendation of Codes Revision Committee, It has now been decided to modify the aforesaid Resolution and allow the following facilities to the individual Scheduled Caste and Scheduled Tribe contractors for execution of P.W.D Works.

I. The Scheduled Caste and Scheduled Tribe applicants desirous of enrolling themselves as Contractors are required to deposit 50% of the amount specified for various Classes of Contractors under Rule-7 of Appendix-VIII (P.W.D Contractors Registration Rules, 1967) of O.P.W.D Code, Volume-II.

II. The concessions / facilities for 10% Purchase Preference shall be allowed only to the individual registered contractors belonging to Scheduled Caste and Scheduled Tribe having Registration Certificate up to "B" Class.

III. If the Tender of the individual registered contractors belonging to Scheduled Caste and Scheduled Tribe is within 10% of the rate quoted by the lowest tenderer for any work, the work may be considered for award to him/her at the lowest tendered rate in relaxation of Rule-18 of Odisha General Financial Rules (O.G.F.R.), Volume-1 and Para-3.5.14 of O.P.W.D. Code, Volume-I.

IV. The Security Deposit (Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/realized by/from the Scheduled Caste or Scheduled Tribe contractors coming under the Categories up to "B" Class only as against the prescribed percentage under Rule-13 of Appendix-VIII (P.W.D. Contractors' Registration Rules, 1967) of O.P.W.D. Code, Volume-11.

10. When in response to a notice calling for tenders, only a single tender is received in the first time. Tender shall be cancelled without opening of bid and fresh tender be invited publicly. If single tender is received, even after re-tendering then the approval of the next higher authority should be obtained, if the tender is otherwise in order and acceptable as per O.M. No. 16 dt. 01.01.2015 of Works Department.

11. Engineer Contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to the effect that he/ she has not availed the facility for more than three works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender shall be rejected.


12. The Bidder shall transfer the required amount of E.M.D /Bid Security @1% of the amount put to tender (mentioned in Page No.1) by online through a process as mentioned in DTCN.

I. The officers authorized by the Procurement Officer – Publisher (Officer Inviting Tender) shall transmit the above documents carefully to the Procurement Officer – Publisher prior to opening of bid. The Procurement Officer – Publisher shall provide signed receipt with date and time for having received the number of documents.

II. Contractor exempted from payment of ED will be able to participate in the tender directly by uploading the documentary evidence towards his eligibility for such exemption.

The successful bidders will have to deposit bid security @1% of the agreement value during execution of the agreement.

13. Conditional tender will summarily be rejected. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.


