1. The Tender Paper along with a non-refundable B.D. amounting to Rs. 2528/- (Rupees Two Thousand five Hundred twenty-eight) only towards the cost of Tender Paper only in favour of DSWO, Nuapada shall be received in the office of the DSWO, Nuapada by Registered Post / Speed Post till dt. ~~18/5/26~~ during the office hours and will be opened on dt. ~~20/5/26~~ at ~~4.30pm~~ in the presence of the Tender Committee Members and Bidders or their Authorized Signatory. The Tender Papers received beyond the date and time shall not be taken into consideration.
2. The bidder must submit an Earnest Money Deposit (EMD) of Rs. **50566 (Rupees Fifty thousand five hundred sixty-six only)** in the form of a demand draft (DD) drawn in Favor of DSWO, Nuapada.
3. The exact number of Material to be intimated at the time of issuing work order.
4. The Tender will be in two parts i.e. Technical Bid (Part-I) and Financial Bid (Part-II). The Tenderer should submit their Technical Bid and Financial Bid separately in two envelopes and put into another cover super scribing in the capital letter such as- "OTHER COMPONENT OF DIFFERENT ITEMS SAKHYAM AWC OF DIFFERENT MATERIAL"
5. The tender paper should be filled in properly and legibly without any correction / over writing.
6. The cost of different items under 'Other Infrastructure Development' shall be quoted on a per-piece basis only. The quoted price must be inclusive of all applicable taxes, transportation, and loading/unloading charges, including installation at Anganwadi Centres (AWCs), wherever applicable.
7. The rate quoted must be, all taxes, duties, transportation cost and loading / unloading charges up to the delivery point i.e. ICDS Projects. The rate quoted should be written both in words and figures in the Tender Paper (Financial Bid). The rate quoted should be final and the tender will not be allowed to change the same under any circumstances.
8. The Tenderer should submit the sample of Material along with other required documents while submitting tender.
9. The committee will verify the sample and lowest rate quoted and the tender will be finalized taking into consideration both the rates quoted by the firm. The decision of the Tender Committee regarding selection of the firms will be final.
10. The selected farms/suppliers shall deliver the items to the AWC of the respective project in Nuapada District within twenty days of receipt of the indent order from the DSWO, Nuapada. The items must meet the Government specifications as per the **Different items under other infrastructure development**. Failure to supply the

materials within the stipulated time may lead to forfeiture of the Security Deposit and/or imposition of a penalty.

11. The items must be neat & clean, good quality and thickness of paper as per the specification. After composition of the format the proof copy should be submitted in the office of the DSWO, Nuapada for verification and approval within three days of the selection of the Tender. Failure to supply the materials in time may lead to forfeiture of Security Deposit / Imposition of Penalty.
12. The bidder has to submit the following documents along with the Tender Paper-
 - (a) BD amounting to Rs. 2528/- (Rupees Two Thousand five Hundred twenty-eight) Only in favour of DSWO, Nuapada towards cost of Tender Paper.
 - (b) Attested copy of PAN Card.

 - (d) Income Tax Return (ITR copies) of Previous year
 - (e) Submit MSME / NSIC Certificate (if applicable)
